AAPA CELEBRATES GRADUATION OF REX AND VIETNAMESE CADETS

The Australian Airline Pilot Academy (AAPA), a wholly owned subsidiary of Regional Express (Rex), based in Wagga Wagga NSW, is today celebrating the graduation of the latest cohort of Rex Cadet graduates and a further three Vietnamese cadets.

The ceremony will be officiated by Guest of Honour, the Hon. Michael McCormack MP, Deputy Prime Minister and Minister for Infrastructure, Transport and Regional Development, and attended by various other distinguished guests from the aviation and local community.

Graduates at this ceremony are destined for Rex and Vietnamese carriers, and they will all receive a Commercial Pilots Licence with a multi-engine Instrument Rating. With this, they will also be accorded a Diploma in Aviation (Commercial Pilots Licence) and a Diploma in Aviation (Instrument Rating).

Rex commenced the unique Rex Pilot Cadet Program in December 2007 in an endeavour to combat a worldwide pilot shortage. Rex is the only Australian carrier to have invested in such a program and provide a meaningful contribution to solving the pilot shortage which continues to grip the aviation industry.

AAPA provides its cadets individual accommodation, fully catered dining and a swimming pool and gymnasium amongst other social and recreational facilities for complete and integrated live-in training.

AAPA is approved on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) and also as a Registered Training Organisation by the Australian Skills Quality Authority (ASQA) to deliver tertiary-level qualifications. In addition to being accredited by the Civil Aviation Safety Authority of Australia (CASA), AAPA is also accredited by the Civil Aviation Administration of Vietnam (CAAV) and the General Civil Aviation Authority of the United Arab Emirates (GCAA).

In November, the Rex Group acquired ST Engineering's training academy based in Ballarat (STAA(A)) which is now renamed AAPA Victoria. AAPA Victoria provides airline cadet training for global carriers and is accredited by CASA, the Civil Aviation Authority of China (CAAC) and the Civil Aviation Authority of Singapore (CAAS), and is currently training 150 cadets from Air China, Hainan Airlines, Xiamen Airlines and OK Airlines, as well as Scoot from Singapore. The acquisition makes the Rex Group one of the largest pilot training providers in Australia.

AAPA Executive Chairman, Mr Chris Hine says the graduation is an exciting time for AAPA and the Rex Group.

"This is an opportunity for us to formally recognise and congratulate another group of cadets that have successfully completed the rigorous course of professional pilot training. It brings us all great pride to have turned these young adults, some of them fresh out of high school some 10 months ago, into fully qualified professional pilots who could be First Officers in a few months' time with a commercial airline."

AAPA currently has training facilities in Wagga Wagga NSW and Ballarat in Victoria.

Appendix A: Establishment of a Pilot Training Academy - AAPA Expression of Interest

Councils interested in responding to this request for EOI are requested to provide details of the benefits of AAPA establishing the new training base at their airport and community including, but not limited to, the provision of the following information;

- 1. Incentives available to AAPA/Rex Group for the development of the academy including;
 - a. Development assistance for the construction of a new training campus. The campus facilities required would be similar to what is present at our campus (www.aapa.net.au)
 - b. Landing charges
 - c. Existing leasing opportunities
 - d. Others
- 2. Land availability, both on and or nearby airport, for the development of an academy campus and accommodation complex for up to 200 students
- 3. Existing aerodrome detail and benefits to pilot training such as;
 - a) Runway configuration
 - b) Taxiway configuration
 - c) Aircraft apron/parking configuration
 - d) Navigation and instrument approach aids
 - e) Refueling facilities and services
- 4. Future aerodrome plans and benefits including in relation to any of the above
- 5. Aerodrome and surrounding airspace architecture and benefits to pilot training
- 6. Proximity to other airport and approach locations and benefits to navigational and instrument flight training
- 7. Existing traffic densities and conduciveness to pilot training
- 8. Weather details and data and conduciveness to flight training
- 9. Access to existing hangarage and or existing opportunities for development
- 10. Existing infrastructure such as airport training/administrative facilities and accommodation facilities that would support an initial operation prior to and during further development
- 11. Benefits of living in the community including shopping, recreation and medical services etc
